



Manufacturers Limited Warranty

Thank you for your interest in THX® INTERCONNECT's products, designed in partnership with Pixelgen Design Inc. This Manufacturer's Limited Warranty applies to Physical Goods and only to Goods purchased from Pixelgen Design or Pixelgen Design Licensed Resellers.

What does this limited warranty cover?

Pixelgen Design warranties all THX® INTERCONNECT products: THX-CBH05, THX-CBH10, THX-CBH15, THX-CBH20, THX-CBH30, THX-CBH50, THX-HFC76, THX-HFC10, THX-HFC15 against defects in materials and workmanship for One Year, beginning on the date of fulfillment. Direct Pixelgendesign.com orders will issue a receipt upon the day of shipment.

The limited warranty applies against defects in materials and workmanship. If a defect is discovered, Pixelgen Design will, at its option, repair or replace the product at no charge, provided it is returned during the warranty period, with return transportation charges paid by the purchaser unless the return is requested by Pixelgen Design.

THX INTERCONNECT products listed above cannot be returned once opened from their original packaging. The limited warranty only applies to defects in materials and workmanship.

Proof of purchase may be required. This warranty does not apply if the product has been damaged by accident, abuse, misuse, or misapplication; if the product has been modified or disassembled without the written permission of Pixelgen Design Inc., or if any Pixelgen Design serial number has been removed or defaced.
